

**Bibliographic Information for the record as follows:**

<b>Author/ Main Entry:</b>	<p>Surname followed by a comma and then fore name.</p> <p>E.g. Goodman, John</p>
<b>Title Statement:</b>	<p>The title must always be written in full including the subtitle. if there is one separated by a colon.</p> <p>A full stop is placed at the end of the title statement.</p> <p>The title is written in lower case letters except for Proper names, and the First letter of the first word of the title.</p> <p>E.g. The quick brown fox: jumped over the lazy dog named Norman.</p>
<b>Call Number:</b>	<p>The Call Number consist of a Universal Decimal Classification Number (UDC) e.g. 330.35 <i>economic growth</i> and a Cutter Number which represents the author's surname using the Cutter tables e.g. <b>B695</b>.</p> <p>A space is always inserted between the UDC number and the Cutter number.</p> <p>The Call Number may also denote:</p> <ul style="list-style-type: none"> <li>• Coordination. Extensions +, / (44+460) France and Spain</li> <li>• Language</li> <li>• Form, e.g. (03) Reference Works</li> <li>• Place (510) China, People's Republic of China</li> <li>• Ethnic Groupings and Nationality (=083) Developing Peoples</li> <li>• Time</li> <li>• Point of View.000.32 Political outlook</li> <li>• General Characteristics (<i>materials, Persons</i>)-058.34 Person with low-income</li> </ul>
<b>Edition:</b>	<p>An edition statement is entered excluding one for the first edition.</p> <p>Standard abbreviations and numerals are used instead of spelled out words.( see AACR2R Appendix <a href="#">C</a>)</p> <p>E.g. 2005 ed <b>OR</b> 3rd ed <b>OR</b> 39 th ed.</p>
<b>Publisher:</b>	<p>Publisher's information is written in the shortest form in which it can be understood and identified internationally.</p> <p>A comma is inserted at the end of the publisher's information. If the name of the publisher is not known the abbreviation [s.n.], for sine nomine is used.</p> <p>E.g. Mc-Graw Hill, Wiley.</p>

<b>Place of Publication:</b>	<p>The place of publication is recorded in the form and grammatical case in which it appears in the item.</p> <p>The name of the country, state, province abbreviated according to .is added to the name of a local place, if it is considered necessary for identification, or for the purpose of distinguishing the place form others with the same name.</p> <p>The name of the country, province or state is enclosed in square brackets if it does not appear in the prescribe source of information.</p> <p>A colon is inserted at the end of the place of publication. If the place is not known the abbreviation [s.l.] sine loco is used. E.g Albany, N.Y.: [Washington, D.C.]:</p>
<b>Date of Publication:</b>	<p>The year of publication of the edition, revision etc. recorded in the edition area is recorded in Western Style Arabic Numerals.</p> <p>If there is no edition statement the year of the first publication of the edition to which the item belongs is recorded.</p> <p>If the date transcribed from the document is known to be incorrect the correct date is added in square brackets.</p> <p>E.g. London: Cambridge University Press, 2004</p>
<b>ISBN:</b>	<p>This number is locates on the Verso of the title page or on the back cover. Enter the complete number without any spaces or dashes.</p>
<b>Physical Description:</b>	<p>This field presents the physical description of the item being catalogued.</p> <p>It contains the number of physical units and parts, recorded in Arabic numerals followed by the specific material designation abbreviated according to AACR2R <a href="#">Appendix B</a>.</p> <p>E.g. V. Volume P. For page or pages. Each of these terms is preceded by the number of units e.g. 436 p.</p>
<b>Subject:</b>	<p>Descriptors relevant to the item being catalogued are entered in this field.</p> <p>Descriptors are taken from the <a href="#"><i>Macrothesaurus: for information processing in the field of economic and social development</i></a>.</p> <p>If no relevant descriptors are found in the <i>Macrothesaurus</i> the <a href="#"><i>Library of Congress Subject Headings</i></a> is used.</p> <p>The librarian adds the descriptor/s to the <i>Macrothesaurus</i> and informs all persons doing coding to add the descriptor/s to their copy of the</p>

	<b><i>Macrothesaurus.</i></b> Use a general subject as the first descriptor.
<b>Notes:</b>	<p>Useful descriptive information which cannot be presented in the other fields is given in notes, to supplement or clarify information given in the preceding areas or provide additional bibliographic information.</p> <p>In notes relating to preceding areas the similar punctuation must be maintained.</p> <p>When quotations from the item or from other sources are used as notes they are enclosed in quotation marks.</p>
<b>URL:</b>	If the printed version of the book also has an online version, the URL is entered in this field. Patron can access the online version from Web OPAC.
<b>Series:</b>	<p>Series information is transcribes according to the rules that govern the title and statement of responsibility. You do not have to put in the brackets.</p> <p>E.g. World Bank discussion paper; 30.</p>
<b>Added Entry:</b>	Enter here authors except the main author and editors. Surname followed by a comma and then fore name. When entering editors put in <b>(ed.)</b> after their name
